The Borrower shall pay to Australasian Premier Trotting Sales (APTS) the Credit Amount together with any additional amounts included by virtue of the Credit Agreement on or before the Due Date specified in the Credit Application Form. Failure to make such payment by the Due Date specified in the Credit Application Form will result in interest becoming due and payable on the total amount outstanding at the rate of 15%p.a. compounded monthly from the Due Date specified in the Credit Application Form until paid in full.
2. During the currency of the Credit Agreement, the Borrower shall keep all and any horses, the subject of the Credit Agreement, insured for their full purchase price in respect of their damage, injury or death from any cause whatsoever and shall use its best endeavours to ensure the policy of insurance bears an endorsement as may, in the opinion of APTS, be necessary to transfer to APTS and/or the Vendor all of the Borrower's interest under such insurance absolutely. If the insurance payment is inadequate to fully discharge the Borrower's liability the total insurance payment is to be directed to APTS in partial satisfaction of the outstanding debt. For that purpose the Borrower hereby appoints APTS its Power Of Attorney to make an direction to the insurer.
3. In the event that the Borrower fails to produce evidence to APTS within one hour of purchase that it has met its insurance obligations pursuant to this clause, the Borrower authorises APTS to enter into such a policy of insurance on the Borrower's behalf and the Borrower shall indemnify APTS in respect of and pay to APTS on demand all costs incurred by APTS in respect of the policy on insurance. Payment of Lots in accordance with the terms and conditions of sale shall not be regarded as made until such charges have been paid.
4. APTS shall retain title, together with evidence thereof, to all or any horses the subject of the Credit Agreement, until all moneys due and payable to APTS pursuant to the Credit Agreement have been paid in full.
5. In the event that the Borrower fails to meet any payment obligations by the Due Date specified in the Credit Application Form, the Borrower acknowledges APTS's right to take all or any action for enforcement thereof available to it. In particular, in the event that the Borrower fails to meet any payment obligations by the Due Date specified in the Credit Application Form, the Borrower consents to immediately being placed on the Unpaid Forfeits List with Harness Racing Victoria.
